Representative example:

For a repayment mortgage of £148,618 over a 29 year term, you will make 24 monthly repayments of £849.82 at 5.44% fixed until 30 June 2026. This will be followed by a further: 324 monthly repayments of £1,160.54 a month at the Homeowner Variable Rate, currently 8.74% for the remainder of the term. The total amount payable would be £396,410.64, made up of the loan amount plus interest (£247,792.64).
