

TSB Yes Days Prize Draw Terms and Conditions.

These terms and conditions apply to the TSB Yes Days Prize Draw. Please take a few minutes to read them and keep a copy for your records.

In these terms and conditions:

- "TSB", "we", "us" and "our" means TSB Bank plc, Henry Duncan House, 120 George Street, Edinburgh EH2 4LH. We are the promoter of this prize draw; and
- "you" or "your" means any person who is proposing to enter into this prize draw as a participant.


1. Who is eligible?

- 1.1. This free prize draw is open to all UK residents, aged 18 or over who hold a TSB personal current account throughout the campaign period in accordance with these terms and conditions.
- 1.2. If you close your TSB personal current account prior to winning and receiving a prize, you won't be eligible.
- 1.3. You will not be eligible if you, or any of your accounts held with us, are subject to any legal restrictions or fraud/financial crime concerns.
- 1.4. You will not be eligible if you, or any of your accounts held with us, are subject to our collections and recoveries process.
- 1.5. Anyone involved in arranging the prize draw will not be eligible to win.
- 1.6. In entering the prize draw, you confirm that you are eligible to do so and eligible to claim any prize you may win. We may require you to provide proof that you are eligible to enter the prize draw.

2. How do I enter?

To be entered into the prize draw, you must meet the following criteria during the Promotion Period 00:01am 20 January 2026 and 11:59pm on 2 March 2026:

- 2.1. Hold an open TSB personal current account.
- 2.2. **Deposit a minimum of £2,500 additional funds into an eligible TSB personal savings account (see section 4 below) during the Promotion Period and leave it there until at least the end of the Promotion Period.**
- 2.3. Funds must originate from outside TSB and must be deposited in pounds Sterling. Any eligible funds deposited into a TSB personal current account during the Promotion Period and onward transferred into an eligible TSB personal savings account during the Promotion Period and left there until at least the end of the Promotion Period will qualify, in line with the terms. Any deposits made in foreign currencies will not be eligible. Standard terms and rates apply for deposited funds. Funds can be withdrawn at any time subject to the applicable account terms and conditions but funds withdrawn before the end of the Promotion Period won't count as qualifying funds.
- 2.4. You can have more than one entry up to a maximum total of 25 entries (see section 2.7 below). For every deposit of £2,500 of qualifying funds you get one entry into the prize draw. For example:
 - Customer A deposits £2,500 on 1 February 2026, then subsequently deposits a further £7,500 on 10 February 2026, which all remains at the end of the Promotion Period. Customer A receives four entries into the prize draw.
 - Customer B opens an eSavings and funds with £15,000 on 20 January 2026, leaving it there till the end of the Promotion Period, they will receive six entries into the prize draw.
 - Customer C opens a Save Well Limited Access ISA and funds £10,000 on 1 February 2026. Customer C withdraws the funds on 25 February 2026. Customer C is not entered into the prize draw.
 - Customer D moves £10,000 from their PCA (existing funds) into a Bond during the Promotion Period. Customer D will not receive an entry into the prize draw as the funds come from another TSB account.
 - Customer E moves £10,000 from their PCA into a Bond after receiving the funds from an external source during the Promotion Period and leaves it deposited till the end of the Promotion Period, in line with the terms. Customer E receives four entries into the prize draw.



2.5. Partial amounts below £2,500 will not count towards an entry, even if they total £2,500. For example:

- £2,500 deposited in two £1,250 payments will not be eligible for an entry.
- £2,500 deposited in five £500 deposits will not be eligible for an entry.
- £10,000 deposited in four £2,500 deposits would be eligible for four entries.

2.6. Joint accounts are eligible only where each account holder is a UK resident and aged 18 or over. Only one entry per £2,500 deposited, regardless of the number of account holders.

2.7. Each eligible entrant may receive a maximum of 25 entries in total. This cap applies regardless of entry route and may consist of, for example:

- Up to 25 entries from deposited eligible funds; or
- Up to 24 entries from deposited eligible funds plus one alternative entry route (see section 2.8 below).

Entrants may not exceed 25 total entries under any circumstances, and an alternative entry route cannot be added on top of 25 entries from deposited eligible funds.

2.8. Alternative entry option: alternatively as a TSB Personal Current Account Customer you can enter the prize draw by writing to us by first or second class post in a sealed envelope to arrive with us during the Promotion Period to: TSB Bank plc Prize Draw, 1st Floor, Henry Duncan House, 120 George Street, Edinburgh, EH2 4LH, with your full name, address, and sort code and account number of your TSB Personal Current Account, requesting to be entered into the TSB Yes Days Prize Draw (only one entry by this route per Customer). TSB will not accept:

- Responsibility for entries that are corrupted, not successfully completed or transmitted, lost, mislaid, damaged or delayed in transit, regardless of cause including, for example, as a result of any postal failure, equipment failure, technical malfunction, systems, satellite, network, server, website, computer hardware or software failure of any kind; or
- Proof of posting or transmission as proof of receipt of entry to the prize draw.

2.9. We are required to be able to notify each winner. You must make sure we have your most up to date contact details. We will not be liable for any failure to comply with any provision of these terms and conditions which requires us to contact or notify you if we do not have your up to date contact details.

3. Opting out.

3.1. By meeting the eligibility criteria and qualifying for an entry into the prize draw, you will be automatically entered into the prize draw and will be deemed to have accepted these Terms and Conditions.

3.2. If you don't want to be included in the prize draw, that's no problem, just head over to tsb.co.uk/savings/opt-out to let us know. Or you can pop into one of our branches or call us on **03459 758 758** (lines open 8am to 8pm Monday to Sunday) and we'll be able to help you. To opt out, you will need to let us know by 3 March 2026 or we may not have enough time to take you out of the draw – but you don't have to accept the prize if you do win.

4. Eligible TSB accounts.

4.1. For the purposes of this prize draw, all TSB personal savings accounts are eligible, except for:

- Monthly Saver;
- Matured Funds;
- Young Saver;
- Young Saver Passbook; and
- Junior Cash ISA.

4.2. Deposits are subject to the individual TSB product terms and conditions, and it is your responsibility to comply with those terms and conditions.

5. What are the prizes and how many prizes will there be?

5.1. There are two cash prizes of £35,000.


5.2. Regardless of the number of entries allocated, each eligible entrant may win a maximum of one prize. If an entrant is drawn as a winner of one prize, they will not be eligible to win the second prize.

6. **Winners, selection and notification.**

- 6.1. The prize draw winners will be selected by random draw from all eligible entries by TSB on or around 20 March 2026.
- 6.2. Winners will be notified directly by TSB by 20 April 2026 using the email address and/or telephone number registered to their account. Notification will be made by whichever of these contact details are available. No postal correspondence will be issued.
- 6.3. Prize funds will be paid directly into each winner's TSB personal current account within 10 working days of notification.
- 6.4. Winners can decline the prize or request the prize funds to be paid to one of the charities we support.
- 6.5. Only winners will be contacted by TSB to notify them of the results of the prize draw. However, a list of the winners will be made available online following the draw (see section 8.5 below).


7. **General terms and conditions.**

- 7.1. This prize draw is an additional promotional benefit and should not influence your decision to select or fund a product; you should base decisions on the product's guaranteed features, including rate and access, and whether it meets your needs, characteristics and objectives. The draw carries a low and non-predictable probability of winning, even where multiple entries are allocated, and should be viewed only as an incremental upside that you should consider before participating.
- 7.2. Where applicable, we may check entry details and ask you for further information to allow us to do this. If the relevant information you have provided or your contact details are not adequate, or if on further review, we determine you do not meet the eligibility criteria for this prize draw, your entry, even if it is the winning entry, may be rejected.
- 7.3. We reserve the right to refuse entry or refuse to award the prizes to anyone in breach of these terms and conditions, or if we've reasonable grounds to believe anyone has gained unfair advantage in participating in the prize draw or won using fraudulent means.
- 7.4. We reserve all rights to disqualify you if your conduct is contrary to the spirit or intention of the prize draw.
- 7.5. If circumstances arise which we couldn't have reasonably anticipated, we may cancel, suspend or amend the prize draw. If this happens, we'll do our best to modify the prize draw to allow it to run but if that isn't possible we may need to suspend or cancel it. We'll do our best to let you know if we need to take any of these steps.
- 7.6. All entries and any accompanying material submitted to us will become our property on receipt and will not be returned.
- 7.7. We will not be responsible for any direct or indirect loss or damage occurring in connection with or as a result of:
 - 7.7.1. this prize draw; or
 - 7.7.2. the suspension or cancellation of this prize draw.
- 7.8. Nothing in these terms and conditions is intended to exclude or limit our responsibility for:
 - 7.8.1. death or personal injury;
 - 7.8.2. fraud; or
 - 7.8.3. any liability that cannot be excluded or limited by law.
- 7.9. Our decision about any aspect of the prize draw is final and binding and we won't enter into any correspondence about it.
- 7.10. Any question about what these terms and conditions mean will be decided based on:
 - 7.10.1. Scots law (and only the Scottish courts would be able to settle any disputes) if your address is in Scotland; and
 - 7.10.2. English law (and only the courts of England & Wales would be able to settle any disputes) if your address is elsewhere.



8. Data protection.

- 8.1. We will process your personal data for the prize draw in accordance with TSB's Data Privacy Notice and applicable laws unless you tell us you do not want us to process your personal data by opting out of the prize draw, in which case we will stop any processing for the purposes of this prize draw.
- 8.2. You can request your right to subject access, rectification, restriction, erasure or portability by sending an email to privacy@tsb.co.uk

- 8.3. If you are unhappy about how we've used your personal information you can complain at any time to the Information Commissioner's Office. They're the supervisory authority for data protection in the UK. You can find their contact details at ico.org.uk
- 8.4. We may ask the winners to take part in post event publicity. Winners do not have to agree to this.
- 8.5. We will make a list of winners' initials (forename and surname only) and the counties in which they live available online on our website following the draw on or around 30 April 2026. We will also contact winners directly to let them know, using the contact details we hold for them. We may still need to share winners' full name and county with the Advertising Standards Authority on request.
